UNIFIED VOICE. AMPLIFIED REACH.

This year, Lutheran Services in America successfully advocated for—and secured—the emergency financial relief legislation necessary to empower not only our own social ministry organizations but also many others on the frontlines responding to the pandemic.

Our advocacy campaigns over the last year mobilized our member organizations to urge their Congressional representatives to support much-needed additional funding for nonprofits, including hazard pay and personal protective equipment.

From our national office in Washington, DC, we amplified the message and engaged lawmakers directly through phone calls, emails and virtual meetings on Capitol Hill.

The collective power of a \$22 billion faith-based voice on Capitol Hill is particularly crucial now to advance policies that improve the health and well-being of the six million people our network cares for each year.

Together, we ensured that our voices were heard for millions of Americans experiencing need.

ADVANTAGE: ADVOCACY

Lutheran Services in America mobilized nearly 1,500 leaders in our network who sent more than 3,000 messages to members of Congress to voice their support or concern over public policy.





AN EXTRAORDINARY CRISIS. EXTRAORDINARY HEROISM.

Through our **Frontline Heroes** campaign, Lutheran Services in America illuminated the efforts of Lutheran social ministry organizations to honor and raise visibility for essential work that often goes unseen. The promotion amplified hundreds of stories from our member organizations across the country. In addition to videos, digital booklets and social postings, we shared the campaign with members of Congress.

Here are a few examples of our members' heroic efforts to find ways to stay connected on behalf of the people in their care:



Lutheran SeniorLife

pivoted from providing hot meals to more than 760 participants in its adult day care centers to handdelivering meals directly to individuals.

Lutheran Social Services of the Virgin Islands

forged partnerships in the community that helped to keep children at the Queen Louise Home and others safe and healthy—and provided for hurricane disaster relief.

KenCrest Centers

used virtual reality to deliver simulated vacations to individuals with intellectual and developmental disabilities in their 12,500 person care community.

SpiriTrust Lutheran

residents have spread kindness and inspiration by painting upbeat words and pictures on rocks placed across the campus, where they offer encouragement and elicit smiles.

Holy Family Ministries

helped to protect its
Westside Chicago students
from violent crime as well
as COVID-19 and instilled
conflict resolution skills
through "Peace Exchange"
programs.

COLLABORATION. COMPASSION. CHANGE.

Through our partnerships with leaders in healthcare, philanthropy, academia and business, Lutheran Services in America advances solutions and drives systemic change in the lives of millions of Americans every year. In spite of the pandemic's challenges, this year we added new partners, introduced innovative programs, expanded existing initiatives and deepened enduring relationships.

In Focus: Strengthening and Preserving Families

Empowering Families.

Our **Results Innovation Lab** has set out to dramatically change the lives of 20,000 children, youth and families by 2024. Through the Lab, we innovate new approaches that strengthen families in crisis and ensure that young people are safe and connected to their communities, schools, jobs and families. A core tenet of the Lab focuses on using data to illuminate and address racial disparities and underlying inequities that stack the deck against children and families of color.

Thanks to partnership support from generous donors, *The Annie E. Casey Foundation, CVS Health, Centene, Harvard's Leadership for a Networked World* and the *ELCA Lutheran Services for Children Endowment*, we are making largescale policy and practice changes in child welfare so families can stay together and live their best life.

"The Results Innovation Lab gave us an invaluable opportunity to reduce the time it takes children of color to find their forever family. This work has had a ripple effect: As an organization, we've grown into better advocates, including within the judicial system, insisting foster care is not lifelong.

We increased permanency by 40% across our organization, greatly surpassing our goal."

In Focus: Aging With Dignity, Choice and Respect

Pivot Power.

Caring for older adults has always been at the heart of our mission: two-thirds of our network provide services across the continuum of care for these individuals. Over the past year, Lutheran Services in America accelerated implementation of innovative models of service that address key gaps in care for low-income older adults.

Older Americans in rural communities show tenacity and strength in their choice to age at home despite harsh winters, strained public services, limited healthcare options and other challenges. The COVID-19 pandemic heightened the challenge of alleviating social isolation and providing key interventions and social support for them.

Our Great Plains Senior Services

Collaborative, with Lutheran Social Service of Minnesota and St. John's United, expanded services and support for people in some of the most rural parts of Minnesota, North Dakota and Montana. North Dakota State University serves as our academic evaluator, helping us to reimagine services to older adults in dozens of rural communities throughout these three states.

During 2020, the **Great Plains Senior Services Collaborative**served 640 adults across 30
rural communities in three
states. Despite the pandemic,
the Collaborative was able to
increase the number of adults
cared for by every program by
more than 100%.

More Successful Transitions Home.

The pandemic widened the gaps in care for older adults to successfully age at home and avoid a return to the hospital following an acute incident. With partnership support from *The Harry and Jeanette Weinberg Foundation* and *The University of North Carolina at Chapel Hill*, we expanded our **Connect-Home Learning Collaborative** to help ensure a successful transition home. The Connect-Home evidence-based transitional care model empowers older adults and their caregivers to manage serious illness at home and prevent avoidable rehospitalizations.

In 2020, Connect-Home enabled
374 older adults in the communities
of Lutheran SeniorLife (Mars, PA),
Niagara Lutheran Health System
(Lancaster, NY) and Luther Manor
(Wauwatosa, WI) to safely transition home.
The program has empowered 875
low-income individuals since 2019.

Scaling a Best-in-Class Model for Staying at Home.

Lower-income older adults too often face challenges accessing reliable nutrition, affordable housing, transportation and companionship. Last year, the pandemic intensified these challenges. We responded with **LSA Senior Connect**, an innovative, person-centered service model led by *Genacross Lutheran Services*. Piloted since 2019, LSA Senior Connect linked older adults with chronic health conditions to the specific resources and support they need.

This year, we partnered with The RRF Foundation for Aging and LeadingAge LTSS Center at the University of Massachusetts Boston to evaluate the impact of enhanced services coordination in low-income and affordable housing communities for older adults.

A NETWORK IN ACTION.

In a time of great uncertainty, in 2020 Lutheran Services in America unleashed the power of Lutheran social ministry to address a unique set of challenges in new and innovative ways.

The Lutheran Services in America Disability
Network continued to be on the forefront
of advocating for person-centered services
that meet the unique needs of people with
intellectual and developmental disabilities. In
2020, LSA-DN came together to carry forward
lessons learned during the COVID-19 pandemic
and to envision and advocate for the next
decade of change we can effect together to

achieve inclusivity, equity and support for people with disabilities.

As part of our commitment to respond to renewed calls for racial equity, we launched the Race Equity Network, focused on advocacy and policy around issues where our members can make an impact on a local and national level. Our Mission Leaders Group is also responding by strengthening the role of spiritual leaders to encourage diversity and equity within their organizations.

At the same time, we pivoted from our annual in-person **CEO Summit** to a virtual four-part, six-seminar series over six months. Despite

the constraints imposed by the panemic, new ideas and out-of-the-box thinking flourished. With record attendance, network leaders with shared missions and values came together in an environment of discovery and trust. They also engaged with top experts in a variety of fields to learn and collaborate on the complex issues their communities face.

In 2020, we also introduced our **Strength & Service Series**, an ongoing virtual gathering of the best minds in our space to address the priority issues they are facing today—all with the goal of moving Lutheran social ministry organizations forward.
