Filling Home and Luther Home of Mercy serves those living with intellectual and developmental disabilities through a system of residential care campuses, small community-based group homes, day programs, in-home services, employment and recreation programs. In addition to mental health counseling, Lutheran Social Services of Northwestern Ohio provides an array of programs and services including food and personal needs pantries, addiction recovery services, financial stability/opportunity programs, citizen re-entry from prison services and works with areas school systems and employers to meet their mental health and community service needs.
