



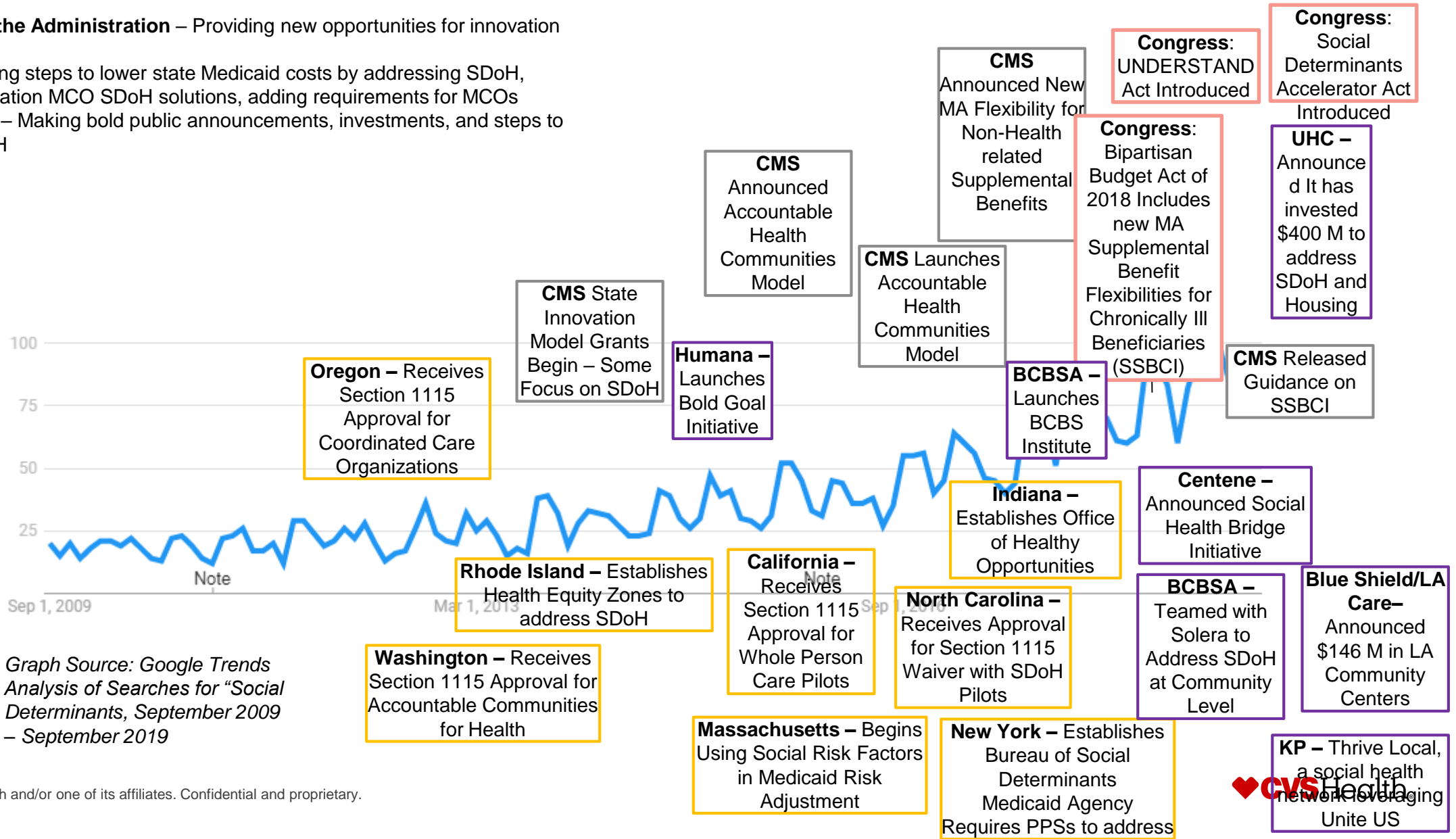

# COVID-19 is fundamentally changing our country, leaving many vulnerable Americans impacted and in need of SDoH support immediately and longer-term

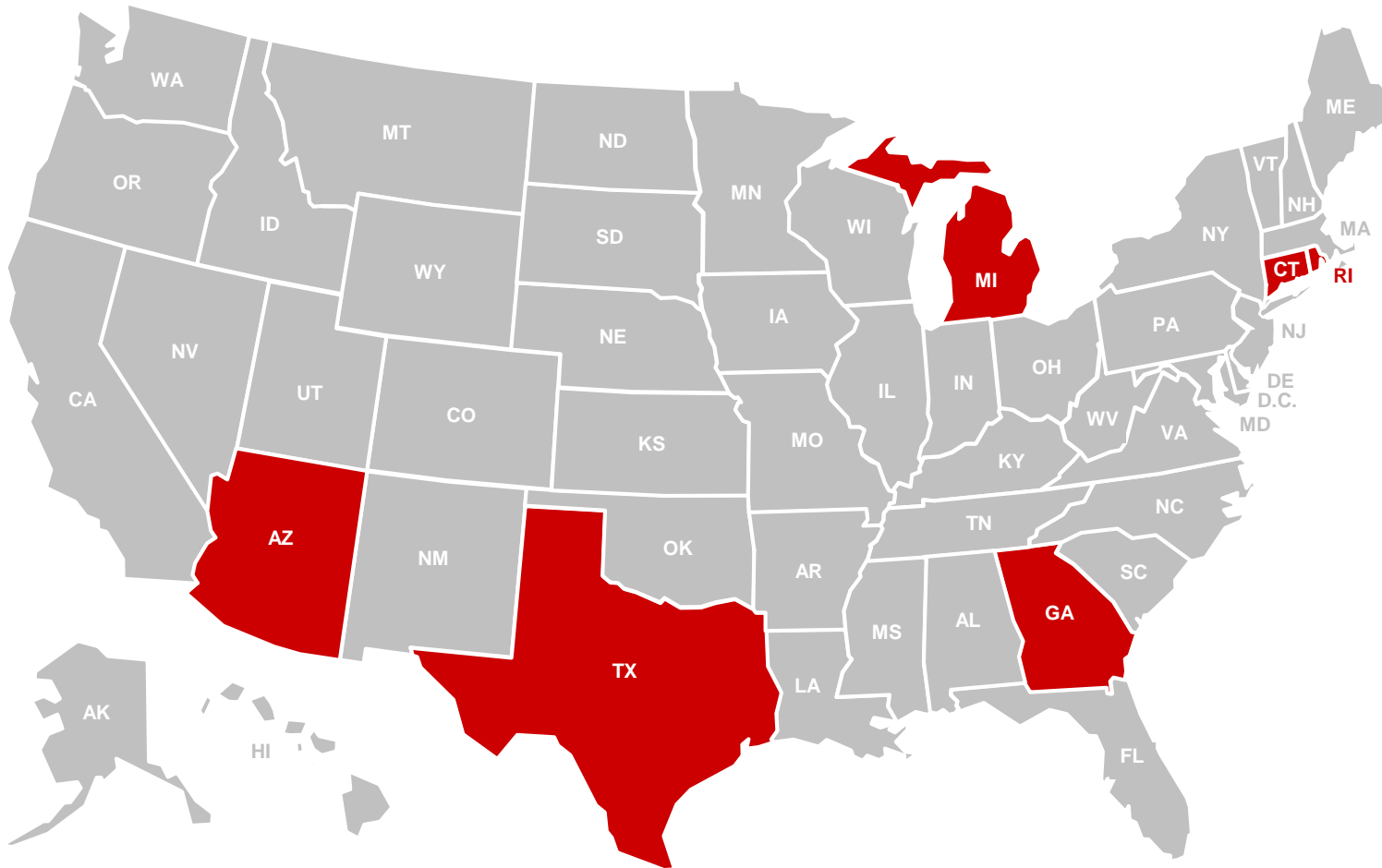
## Increased access to testing *(near-term)*

Lower income communities are under-tested and over-risk than the general population, due to the nature of their work as essential workers with greater daily exposure to other people, using public transportation, etc. (i.e. truck drivers, warehouse workers, skeleton restaurant/hospitality workers)

## Sustained SDoH support *(longer-term)*

In addition to the pandemic itself, we will see long-lasting economic consequences across the country with many Americans struggling to meet their and their families' SDoH needs through at least the end of the year, if not longer.


# Community Testing Sites



## Community Testing Site Approach

In addition to making testing available at approximately 1,000 CVS store locations, we are partnering with community organizations to establish additional sites for underserved communities. Testing at these locations will be open to the public by appointment at no cost. Testing is conducted inside the community site location and individuals can walk up to access testing (no vehicle required). On-the-spot results will be provided to patients. To be eligible for testing, patients will need to meet criteria established by the CDC, in addition to age guidelines.
